

NWSS DRY GRAD 2022 - CONSENT AND WAIVER

In consideration of the Dry Grad Committee offering my child [or myself, if over 19 years of age], an opportunity to participate in the Dry Grad, taking place on June 23 2022, I waive any and all claims I may have against and release from all liability and agree not to sue, the Dry Grad Committee or and of its members, officers, representatives, agents, trustees, servants, chaperones or volunteers for any personal injury, death, property damage or loss sustained as a result of, related to, in connection with, or occurring during my child's participation in Dry Grad, including any events arising at Central City Fun Park, providing the Dry Grad Committee has not engaged in gross negligence or willful misconduct.

I am aware of the risk and dangers inherent in participation in all of the activities associated with Dry Grad, and of the possibility of personal injury, death, property damage, or loss resulting from the activities. The dangers and risks may include, but not limited to; equipment breakages, conduct of the volunteers, chaperones, agents or other group members, human error, risks associated with participation in games and activities, or transportation to and from the Premises [collectively, the "Risks"] or the possibility that my child [or myself if over 19 years of age] may not heed safety instructions or restrictions given to the group or to them individually.

In consideration of being permitted to participate in the Dry Grad Event and to access and use the premises, the Participant and Participant's Guardian [if applicable] hereby: [a] releases, discharges and forever holds harmless Central City Fun Park, the 'NWSS dry grad committee' and all of their respective members, partners, sponsors, agents, affiliates, directors, officers employees and volunteers [collectively, the 'Releasees'] from any and all liability for damages or losses arising as a result of the Risks or arising from breach of contract, breach of statutory duties of care [including any duties of care under the Occupiers Liability Act of British Columbia], or negligence on the part of the Releasees and [b] freely assumes the Risks and anything incidental to the Risks which may arise as a result of or in connection with participation in the Dry Grad Event or access to and use of the Premises.

I am not relying on an oral or written representation of statements made by the Dry Grad Committee and its members, officers, representatives, agents, trustees, servants, or volunteers, to induce me to permit my child [or myself if over 19 years of age] to participate in Dry Grad, other than those set out in this Consent and waiver.

BY PURCHASING A TICKET FOR THE EVENT, YOU ARE GIVING UP LEGAL RIGHTS TO ALL CLAIMS AGAINST THE RELEASEES. YOU CONFIRM THAT YOU HAVE READ AND FULLY UNDERSTAND THIS ACKNOWLEDGEMENT AND RELEASE.
